2. Terminology used

"Court addressed":

The court which is asked to recognize or enforce a judgment.

"Court of origin": The court which rendered the judgment.

"Ground for refusal":

A circumstance in which the recognition or enforcement of a judgment otherwise entitled to recognition and enforcement may be refused.

"Jurisdictional filters":

Also called "indirect grounds of jurisdiction". Criteria for determining whether a judgment is entitled to recognition and enforcement by reference to the ground of jurisdiction on which the judgment was based.

"Recognition":

The Hartley-Dogauchi Report defines "recognition" as the court addressed giving effect to the determination of the legal rights and obligations made by the court of origin (para 170).

"Enforcement":

The Hartley-Dogauchi Report defines "enforcement" as the application of the legal procedures of the court addressed to ensure that the defendant obeys the judgment given by the court of origin (para 170).

"State addressed":

The State in which the court addressed is situated. Equivalent to the term "requested State" in the 2005 Convention on Choice of Court Agreements.

"State of origin":

The State in which the court of origin is situated.
